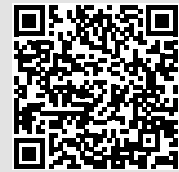

## 1 Information about the collection of personal data

(1) Below you will find details of how we collect and process personal data in the course of conducting contractual relationships and in other situations in which you contact us. ## 2 Collection of personal data

(1) When you get in touch with us via email, a contact form or through other means, we store the data you share with us (e.g. your name and e-mail address or your name and phone number), so that we can answer your questions and handle your queries. We delete the data we collect in this context when it is no longer required, or restrict its processing if we are legally obligated to keep it on file.

If you disclose personal data to us within the context of the contract, inquiries relating to our products and services, or order requests and any subsequent communication relating to the order, we will use this data for the following purposes:

- > to enable us to process contract-related matters and/or associated inquiries;
- > to enable us to fulfill contracts that we have concluded with you and to perform services and fulfill orders in accordance with the agreement we have made with you;
- > for invoicing, asserting our claims and (only where necessary) collecting payments;
- > to handle any instances of disruptions in performance;
- > for any further subsequent disputes, particularly, where applicable, those of a litigious nature;
- > to fulfill our legal retention and documentation obligations, particularly those under commercial and fiscal law;

If data is processed to enable us to fulfill contractual obligations and other requirements relating to the contractual relationship, Art. 6 para. 1 sentence 1 lit. b GDPR provides the legal basis for such. If data is processed to enable us to fulfill our legal retention and documentation obligations, particularly those under commercial and fiscal law, Art. 6 para. 1 sentence 1 lit. c GDPR provides the legal basis for such. If we process personal data on the basis of the data subject's express consent, Art. 6 para. 1 sentence 1 lit. a GDPR provides the legal basis for such. We also reserve the right to use personal data, to the extent permitted by law, for the purpose of sending information regarding additional products and services. In this case, data processing is carried out on the basis of Art. 6 para. 1 lit. f) GDPR, whereby our legitimate interest lies in advertising and promotion as well as the maintenance of existing business relationships.

(2) The information is stored for as long as it is required for the respective purpose. It is deleted when the statute of limitation for any potential claims expires, provided a longer retention period is not prescribed by commercial or fiscal law, whereby in the latter case, it is deleted upon expiry of the retention period. Data shall only be stored for an extended period of time if you have given us your express consent to do so or if ongoing transactions or proceedings prevent its deletion. We only pass on your personal data if such is required for the purpose of contractual cooperation, e.g. to deliver goods to the address you have provided using transport companies or — only where necessary — to collection agencies and other companies we work with. The legal basis for disclosing your personal data to such contracting parties is Art. 6 para. 1 lit. b) GDPR, in addition to our legitimate interest in the efficient management and processing of the service relationship, e.g. providing a direct response to technical and specialized questions (Art. 6 para 1 lit. f) GDPR). If we pass on your personal data with your consent, Art. 6 para 1 lit. a) GDPR provides the legal basis for this disclosure and further processing. The legal basis for the processing of payments is Art. 6 para. 1 sentence 1 lit. b) and, where you have given your consent, lit. a) GDPR.

## 3 Your rights

(1) You have the following rights with respect to the personal data concerning you:

- > right of access,
- > right to rectification or erasure,
- > right to restriction of processing,
- > right to object to processing,
- > right to data portability.

If you have given consent for your data to be processed, you can withdraw this consent at any time. If such consent is withdrawn, this will affect the legitimacy of the processing of your personal data after you have informed us of your wish to withdraw your consent.

(2) You also have the right to lodge a complaint relating to our processing of your personal data with a data protection supervisory authority.
